DISCUSSION AND CONSIDERATION OF POSSIBLE EXTENSION OF PUBLIC REVIEW AND COMMENT PERIOD FOR THE DRAFT ENVIRONMENTAL IMPACT REPORT REGARDING MARINE PROTECTED AREAS IN THE CALIFORNIA SOUTH COAST STUDY REGION PURSUANT TO THE MARINE LIFE PROTECTION ACT. **Acting Executive Director described the current CEQA review period, along with review periods resulting from 15, 30, and 45-day extensions to the comment period. Received public testimony.**
