Section 510, Title 14, CCR is amended as follows:

§510. State Duck Stamp.

Any ~~adult license holder~~ licensed hunter taking ducks, geese, or brant must have a current state duck stamp ~~affixed to their license validation~~ in his or her possession. Any person hunting under the authority of a valid junior hunting license is exempt from this section.
