REGULATORY LANGUAGE

Section 310.5, Title 14, is amended to read:

§ 310.5 Shooting Hours for Upland Game Birds.

The shooting hours for all upland game birds, except for pheasants and the spring wild turkey season, shall be from one-half hour before sunrise to sunset. The shooting hours for pheasants shall be from 8:00 a.m. to sunset. The shooting hours for the spring wild turkey season shall be from one-half hour before sunrise to ~~4:00~~5:00 p.m.
